IN 2015 THE FOOD BANK DISTRIBUTED 23 MILLION POUNDS OF FOOD TO OUR PARTNER AGENCIES AND THE FAMILIES AND INDIVIDUALS THEY SERVE, PROVIDING 19 MILLION MEALS FOR MAINERS IN NEED.
