1 Briefly describe the organization's mission: The mission of Good Shepherd Food Bank is to eliminate hunger in Maine by improving access to nutritious food for people in need, building strong community partnerships, and mobilizing the public in the fight to end hunger.

Food Distribution: Good Shepherd Food Bank (GSFB) provides for those at risk of hunger by soliciting food donations and purchasing food at wholesale prices, then distributing this food to more than 500 partner agencies across Maine, including food pantries, meal sites, shelters, schools, afterschool programs, child care centers, senior centers, and other community organizations. In its 2020 fiscal year, GSFB distributed more than 35 million pounds of food to partner agencies and the families and individuals they serve, providing over 29 million meals for Mainers in need.

4b (Code:) (Expenses \$ 997,826. including grants of \$ 12,000.) (Revenue \$ 0.) Mainers Feeding Mainers: this program is the Food Bank's collaboration with local farms to purchase and distribute nutritious, Maine-grown food. Each year, the Food Bank makes purchases of fresh Maine vegetables, fruits, grains, and dairy products on behalf of partner agencies. The Food Bank also receives donations from many local farmers. In calendar year 2019, the Food Bank distributed 2 million pounds of local foods and invested over \$750,000 into Maine's agricultural sector.

4c (Code:) (Expenses \$ 1,360,323. including grants of \$ 234,188.) (Revenue \$ 83,406.) Youth & Families Initiatives: Good Shepherd Food Bank operates the School Pantry Program to provide easy, consistent access to nutritious food for students and their families. Our school partners not only serve as food distribution sites in vulnerable areas, but also function as vital community resource hubs where families feel welcomed, supported, and safe. In addition, the Food Bank operates an afterschool meal & snack program called Kids Cafe and the Summer Food Service and Child & Adult Care Food Programs in Bangor and Brewer. In collaboration with 228 program partners, GSFB distributed over 2.3 million meals to more than 21,000 families statewide through Youth & Family Initiatives in FY2020.

In January 2007, GSFb transferred funds to the Maine Community Foundation (the "Foundation") to establish an endowment fund with GSFb named as beneficiary. Under terms of the agreement, a percentage of the market value of the fund ("annual spending policy") shall be paid and distributed to GSFb at least annually, or on a schedule to which the parties may from time to time change. GSFb can withdraw all or a portion of the original amount transferred, any appreciation on those transferred assets, or both, provided that a majority of the governing boards of GSFb and the Foundation approve of the withdrawal. At the time of the transfer, GSFb granted variance power to the Foundation. That power gives the Foundation the right to distribute the investment income to another not-for-profit

organization of its choice if GSFB ceases to exist or if the governing board of the Foundation votes that support of GSFB (a) is no longer necessary, (b) is incapable of fulfillment, or (c) is inconsistent with the needs of the community. At June 30, 2020 and 2019, the endowment fund has a value of \$279,916 and \$280,746, respectively, which is reported in the statements of financial position as a beneficial interest in assets held by others and board designated endowment.

GSFB is exempt from federal and state income taxes under Section 501(c)(3) of the Internal Revenue Code and comparable state law and, therefore, has made no provision for income taxes in the accompanying consolidated financial statements.

Tax-exempt organizations could be required to record an obligation for income taxes as the result of a tax position they have historically taken on various tax exposure items including unrelated business income or tax status. Good Shepherd Food Bank engages in many other activities that are nevertheless important to its core principles and mission. The most significant of these other program service accomplishments are as follows:

Cooking Matters Maine: an outreach program that mobilizes culinary and nutrition professionals to teach cooking and nutrition classes to low-income adults, teens, and children. Classes are taught at local community centers, schools, and food pantries, and the classes provide people at risk of hunger with hands-on cooking and nutrition experience. In fiscal year 2020, the program offered 189 Cooking Matters classes and 173 store tours to more than 4,600 participants.

Critical Response Program: The Food Bank operates a mobile food pantry to reach underserved areas of Maine. In fiscal year 2020, the Food Bank distributed nearly 122,000 pounds of food through 36 Food Mobile deliveries. The Food Bank provided nearly \$650,000 in pandemic support grants to 375 agencies to support the operational shifts, increased food needs, and personal protective equipment needed to continue their food distributions safely during the pandemic. Additionally, through funding provided by foundation partners, the Food Bank provided grants of over \$112,000 to 51 partner agencies to help build the necessary

Community Health and Hunger: the Food Bank forms partnerships with health care organizations to reduce the negative impact of food insecurity on health outcomes. Through the program, the Food Bank provides training and technical assistance for health care providers implementing food insecurity screening and referral to food resources, and supports projects that directly distribute food in health care settings for patients in need. In fiscal year 2020, the Food Bank worked with 110 sites to provide nearly 140,000 pounds of food to people who screened positive for food insecurity.
